2017 Membership Benefit Plan Info

Full Membership:

Full members may participate in all club activities. They are allowed full use of the pool and tennis courts. They may bring guests. Each full member family has one vote in Board of Directors elections and votes by the membership. Full members may be elected to the Board. Annual dues are \$350 with a \$100 maintenance fee. Maintenance fees may be offset by eight (8) maintenance work hours overseen and signed off by a Board member.

Single Membership:

A Single membership applies to one individual only. That individual enjoys full club privileges. No other persons are included in this membership, regardless of relationship. Dues are \$175. Maintenance fees are \$50 and may be offset by four (4) maintenance work hours overseen and signed off by a Board member. Single members have a vote in Board of Directors elections and votes by the membership. Single members may be elected to the Board.

Grandparent Membership:

Grandparent membership allows visiting (that is, not living with the grandparent(s) full-time) grandchildren to use the pool or tennis courts subject to certain restrictions: Grandchildren must be supervised. Grandchildren may not bring guests. Total visits must be substantially less than the full summer season. Dues are \$125. There is no maintenance fee.

Social Membership:

Social Membership is offered to adults age at least 21. Members will be invited to and may participate in the social activities of the club. Access to the pool deck and use of the pavilion and grill is included. Social membership does not include use of the pool, tennis courts, or the option to invite guests to use the pool or tennis courts. Dues are \$100. There is no maintenance fee.

Tennis-only Membership:

Tennis-only membership entitles the member family to use the tennis courts and to participate in any Club activities specifically sponsored by the Tennis Committee or conducted for the benefit of the tennis facilities. Tennis membership does not allow for the use of the swimming pool. The pavilion and bath house will be available for tennis members during pool hours or other periods allowed by the Board of Directors. Annual dues are \$100. Maintenance fees are \$25 and may be offset by two (2) maintenance work hours overseen and signed off by a Board member.
